To All family members of a current Resident at St. Martin's and to our friends

At the very beginning of the COVID-19 pandemic, we made a commitment to keep you informed regarding the impact of the coronavirus on our Residents, the Little Sisters and our staff. We are happy to report that all of this week's round of tests, which were completed on Monday, were negative. We are still waiting for a few more test results that were done later in the week.

As we see on the news, the number of cases and hospitalizations in Maryland is down. However, the significant resurgence of the coronavirus within many neighboring states over the last few weeks continues to impact our planning for a phased reopening of visits to our home. For the continued good health of those in our care, it is important that we move forward thoughtfully, carefully, and safely.

Through the goodness of God and the protection of St. Joseph, since we have no new cases to report we have received the authorization to begin to schedule outdoor visits for the Residents and their families. Because of this, we have worked diligently on revisions to our reopening plan while being very aware of the ever-changing landscape.

It is with enthusiasm and caution at the same time, that we are attaching our plan for outdoor visits with your loved one. We ask that you please read the plan and if you agree with it, then please sign the consent form and email it back to Mary, our Social worker. After we have received your consent form back, then we can work together on choosing a date for your visit.

I personally cannot thank you enough for your patience and understanding during these unprecedented times.
